In April of 2002, the Ontario Provincial Police – Criminal Investigation Branch initiated a homicide investigation after the remains of the victim of this investigation, eighteen (18) year old Riad BAROUD, were located off of Vasic Line in the Municipality of Chatham-Kent.

The victim was of Arabic decent who had chosen to remain in Canada after his family was deported in 2000. The victim had become close to the suspect and his family and was also employed at the suspect's legitimate business, known as "Pizza Supreme 2 for 1," previously located in the City of Windsor, Ontario.

The suspect and victim were also actively involved in the illicit drug trade, which is the suspect's primary source of income.

The homicide investigation revealed that the victim became financially indebted to the suspect and as a result, on April 22nd 2002, the victim was taken from the City of Windsor by the suspect. The victim was bound and restrained, then extensively beaten, eventually succumbing to his injuries. The suspect then drove the victim to an isolated area in the Municipality of Chatham-Kent, where he dumped the victim's body in a bush lot. The victim's remains were subsequently discovered by a road-grader operator on April 25th 2002.

The suspect was believed to have fled Canada for Laos after this offence. However it is now believed that he may have returned to Canada and potentially residing in the Cities of Toronto, Montreal or Vancouver.
